STRENGTHENING YOUR NON-PROFIT: DISASTER PREPAREDNESS

Disaster preparedness is crucial for non-profits to maintain services during emergencies. This article offers simple steps to protect your team and those you serve, ensuring readiness in unpredictable times.

- 1. <u>Workplace:</u> Could you function and do business if your physical location was inaccessible or destroyed? Think about what plans or equipment you would need to continue your work. Plan for operations if your location is inaccessible. Consider creating an emergency evacuation plan from your office, securing backup locations, and acquiring secure entry methods for law enforcement such as a keypad.
- 2. **Communication:** Ensure you have backup communication systems like Zoom or alternate phone lines. Prepare a press release template and contact lists for staff to communicate with your stakeholders. Include information about ways to contact you.
- 3. **Records:** Store important documents, passwords, and bylaws securely, either on backup drives or in the cloud. Make sure it is accessible to key people.
- 4. **Partnerships:** This could be an agreement to use the workspace of a local partner in the case yours becomes inaccessible. Inform key partners in your community in the case you are unable to continue operating during the time of transition.
- 5. <u>Assess Technology:</u> Ensure your systems can operate remotely and that you have portable devices like laptops for your team. Budget for any necessary upgrades.

By following these steps, your non-profit can continue to support your community, even in challenging times. Stay proactive and prepared to make a difference when it matters most.
